

INTEGRITY POLICY

Pausit AB Aktiebolag (the "Company"), org.nr 556690-8132 Älvtomtagatan 12, 703 41 Örebro safeguards personal privacy and is careful that your personal data is processed correctly, i.e. only for intended purposes and protected against unauthorized access. All processing of personal data takes place in accordance with the General Data Protection Regulation (GDPR).

1. Pausit Software

The Pausit Software collects data about its use on the licensed user's own computer where it is stored locally. The purpose of this data is to enable the user to follow their own progress. The Company guarantee that no data from the user's own use of the Program is stored, forwarded or otherwise made available to Pausit or any other third party. For more information about what data the application Pausit stores, see paragraph 7 in this document.

1.1 The personal data processed centrally by the Company aims to complete financial, support and licensing matters: For legal persons, contact information about the organization's contact person(s) is stored and for private customers names, social security numbers and contact details are stored. Data sent encrypted over the internet is license-related and only for the purpose of managing the unique subscription and does not contain any personal data.

2. Collection of personal data in contacts with us

When you send us an email or use our contact forms on the website, we save your contact information for the purpose of completing our dialogue and we save your data such as email address and possibly phone number until the purpose of our dialogue is fulfilled and no more than one year thereafter. When you have requested a quote from the Company and are not yet a customer, the quote is saved for two years along with the contact details of the person who requested the quote. The e-mail address provided may receive newsletters from us in order to spread knowledge about the Company and its products. Deregistration is possible in each newsletter.

3. Storage of personal data when you are a customer of ours and time thereafter

When you have entered into a license agreement with us, we store personal data in accordance with paragraph 1 above. If your contract expires, we save personal data to contact persons for a maximum of three years in order to fulfill any warranty and complaint matters and to be able to market relevant products. You can request that marketing cease at any time by contacting us.

4. Recipients of data, data processors

4.1 Service providers and retailers

We share your personal data with resellers of Pausit Software to be able to contact you by phone and email and inform about the Software via newsletter. Our resellers per country can be found in our website. We may also share your personal data with companies that provide services to us, for example, to manage newsletters. These companies may only process your personal data according to our instructions and may not use your data for any other purpose. This is established in agreements with our service providers.

4.2 Other recipients

We may transfer your personal data in accordance with paragraph 1.1 to authorities, if required by us by law. If all or part of our business is sold or integrated with other activities, your personal data may be disclosed to our advisors, potential buyers and their advisors and passed on to the new owners of the business for the purpose of fulfilling the original agreement.

5. Use of Cookies

Our Website in Wordpress uses cookies in order to improve your user experience and to give you as a visitor access to certain functionality. These cookies only provide a random number and are not linked to your identity. We also use cookies from Google Analytics to measure and evaluate our website and make it more user-friendly. We anonymize the IP addresses within the framework of Google Analytics tools so that these cannot be tracked or linked to individuals. We also use cookies that are linked to Pausit's advertising, this is called tracking. It enables Pausit to reach those who have visited our website with ads, e.g. in Facebook. You can opt out of these cookies the first time you visit our website.

Turning off cookies

If you do not accept the use of e.g. cookies on our website, you can change your browser settings so that no cookies are stored on your computer. We refer to your browser's user manual for more detailed instructions. Keep in mind that some features may not work properly if you completely turn off the use of cookies.

6. Your rights

You have the right to request from the Company access to and rectification of your personal data. You also have the right, in some cases, to request a restriction on the processing concerning you, to object to the processing and to have certain data deleted. You also have the right to receive the personal data that concerns you and that you have provided to the Company.

7. Pausit user data specification

Pausit guarantees that:

- No data can be traced to user and user-usage of the program;
- No data is stored, transmitted or otherwise made available to Pausit or any other third party;
- The information that the application saves about the use of the program is for personal use and is stored only in the locally installed application.

Below a specification of all data, related to users and customers, that is communicated or stored by the Pausit application and Pausit's license server:

A. Data stored locally for the user

The following data is stored in a database file on the user's computer, in their home directory:

- User settings, for example:
 - Instructor appearance
 - Language
 - Training schedule
 - Enabled exercise types
 - Favorite exercises

- User statistics
 - Number of total completed exercises
 - Number of completed exercises per day
 - Number of times an exercise has been completed
 - Timestamp of when an exercise has last been completed

The license key is stored in an encrypted file in the users home directory and the installation directory of the application.

B. Data stored by Pausit

The following data is stored on the internet, in the Pausit license server:

- License information
- Company name
- License number
- Licensing data
- License activations
- License number
- Device unique identifier
 - Hash of a concatenation of strings from Computer System Hardware Classes
- Timestamp when activation was performed

C. Data communicated between Pausit and the user

The following data is sent over the internet, via HTTPS, from the application to the license server:

- License key
- Device unique identifier (as above)
